

## LETTER FROM THE IPI DIRECTOR



Dear friends of IPI:

For eight-and-a-half months, FY2020 was a pretty typical year, filled with the typical challenges and typical opportunities that any year brings. And then, within just a few days into March, the world was radically changed

by the novel coronavirus. For our staff and their loved ones, and the men and women that we supervise, life was disrupted in the most un-typical ways.

Despite this disruption, or maybe because of it, the men and women of IPI rose to the occasion. The worldwide pandemic demonstrated dramatically the skills and dedication of our staff and our associates.

The virus has sickened hundreds of DOC staff and thousands of incarcerated individuals, and so our first priority from the outset was to protect the health and well-being of our staff and associates, and secondly to maximize the supply of products that the Iowa citizens needed to ensure their own health and safety.

As the institutions and world around us shut down, there was an outcry for PPE and hand sanitizer from the DOC institutions, state agencies, schools and universities, nursing homes and virtually every organization. Working seven days a week, the men and women of IPI leaped into action, manufacturing amazing quantities in record time:

Cloth Isolation Gowns 47,852
Face Shields 26,267
Hand Sanitizer (gallons) 27,936
Masks and Sneeze Guards 131,632

In addition, IPI manufactured and distributed record amounts of disinfectants and sanitizers for worried customers across the state. All the while, our shop staff and associates wore both a cloth mask and a plastic face shield. Every single member of IPI pitched in, whether it be making a rush pickup of deionized water needed for manufacturing hand sanitizer or an expedited delivery of gowns to an anxious long term care facility.

This tremendous accomplishment was publicly recognized by Governor Kim Reynolds, IDOC Director Beth Skinner, the Iowa Board of Parole, and even U.S. Senator Charles Grassley on the floor of the U.S. Senate.

For those staff that could, working from home became the norm. Fortunately the IPI organization had been using online meetings and shared documents for a few years, and we were prepared.

Activity-wise, the first 8-1/2 months of FY2020 were strong, but that was followed by 3-1/2 months of restricted movement and customer shutdowns. Work training hours grew slightly to 904,204 (435 FTEs), Net Sales grew 15% to \$30.6 million, and Net Sustainable Income, which funds purchases of machinery, equipment and vehicles for the IPI program, finished at a breakeven \$12,218. For IPI Farms, continued low commodity prices led to a loss of \$266,593 on revenues of \$1,976,231.

Although the path forward into FY2021 remains murky, our Vision of providing meaningful work training opportunities for every person remains crystal clear. We know through research that work training and vocational education are among the most important factors in ensuring success for the thousands of men and women that return to Iowa communities every year from state prison.

I know that you share my tremendous pride in the men and women that make up the IPI program, so please stay safe, and enjoy our FY2020 Annual Report!

## **IOWA CODE §904.801 – STATEMENT OF INTENT**

It is the intent of this division that there be made available to inmates of the state correctional institutions opportunities for work in meaningful jobs with the following objectives:

- To develop within those inmates willing to accept and persevere in such work:
  - **a)** Positive attitudes which will enable them to eventually function as law-abiding, self-supporting members of the community;
  - **b)** Good work habits that will assist them in eventually securing and holding gainful employment outside the correctional system;
  - c) To the extent feasible, marketable skills that can lead directly to gainful employment upon release from a correctional institution.


- To enable those inmates willing to accept and persevere in such work to:
  - a) Provide or assist in providing for their dependents, thus tending to strengthen the inmates' family ties while reducing the likelihood that inmates' families will have to rely upon public assistance for subsistence
  - b) Make restitution, as the opportunity to do so becomes available, to the victims of the offenses for which the inmates were incarcerated, so as to assist the inmates in accepting responsibility for the consequences of their acts;
  - c) Make it feasible to require that such inmates pay some portion of the cost of board and maintenance in a correctional institution, in a manner similar to what would be necessary if they were employed in the community;
  - **d)** Accumulate savings so that such inmates will have funds for necessities upon their eventual return to the community.

### Wage Disbursement for Private Sector Offenders


