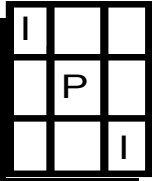

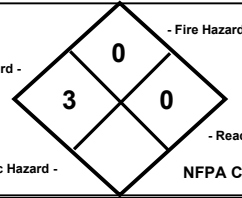

Eyes: Immediately flush eyes with running water for at least 15-20 minutes, keeping eyelids open. Get medical attention.

SECTION 9 - SPILL OR LEAK PROCEDURES

Steps to be Taken if Released or Spilled- Evacuate unprotected personnel from area. Wear proper protective equipment including rubber boots. Ventilate area if needed. Stop leak if you can do so without risk. Dike or dam large spills. Avoid direct discharge to sewer and surface waters. Pump or scoop to container or soak up with non-combustible inert absorbent materials. After spill collection, rinse area with water and follow with normal clean-up procedures. Be careful as spills are slippery.
Waste Disposal Methods- Undiluted product is regulated under environmental and transportation laws as a corrosive waste (RCRA Class D002). Dispose of according to all federal, state, provincial and local laws and regulations. Consult state and local authorities for restrictions on disposal of chemical waste. Manage chemical wastes through an approved waste treatment facility. Do not reuse empty container. Rinse empty container thoroughly with water before discarding container in accordance with current local community codes. Please recycle empty container whenever possible.

SECTION 10 - STORAGE AND HANDLING INFORMATION

Precautions to be Taken in Handling and Storage- HANDLING: Follow all label directions. Instruct personnel about proper use, hazards, precautions, and first aid measures. Avoid inhalation, ingestion, and contact with skin, eyes and clothing. Do not taste or swallow. Remove and wash contaminated clothing and footwear before re-use. Product residue may remain in empty containers. Handle carefully to avoid damaging container. STORAGE: Rotate stock regularly. Keep container closed when not in use. Avoid temperatures below 35°F or above 120°F. Protect from freezing. Storage at ambient temperatures in a dry area out of direct sunlight is recommended. Keep away from food and drink. Keep out of children's reach.
