## TO WHOMSOEVER IT MAY CONCERN

On June 19, 2020 FDA advised consumers not to use any hand sanitizers manufactured by Eskbiochem SA de CV in Mexico, due to the potential presence of Methanol (wood alcohol), a substance that can be toxic when absorbed through the skin or ingested. Additionally FDA asked consumers who have been exposed to hand sanitizer formulated with methanol to seek immediate treatment, which is critical to avoid potential toxic effects related to methanol exposure.

Note: Only Ethanol and Isopropanol are approved active ingredients for alcohol based hand sanitizers in North America

Diversey's Alcohol based Hand Sanitizers in North America are formulated using only the FDA/Health Canada approved active ingredient Ethanol. Further, these agencies regulate the level of potentially hazardous impurities that are allowable in hand sanitizer formulas. Hence, Diversey ensures that any unavoidable levels of these impurities that may be present in our ingredients are as low as feasible and fall below the maximum levels allowed by FDA and Health Canada. Methanol is not used as a raw material or as an ingredient in Diversey's Hand Sanitizer products.

Diversey's Alcohol based Hand Sanitizers are in full compliance with FDA and Health Canada Regulations. We are confident in the safety profile of our products when used as directed based on our rigorous assessment process and long history of safe product use.
