# Website Upgraded With New Shopping Features

On December 30, 2011, after nearly nine months of research, testing, planning and updating, IPI launched its new, fully-functional e-commerce website at <a href="http://www.iaprisonind.com">http://www.iaprisonind.com</a>.

For years, the IPI website has functioned well for our customers and IPI staff; but as technology has improved, the site lacked convenient features that other shopping websites contained.

Customers shopping on the new IPI website are enjoying a host of new features such as:

- Saving shopping carts to order later
- · Building wish lists
- Built-in volume discounts
- Expanded product descriptions and specifications
- More literature downloads
- Searchable product database
- Saving multiple shipping addresses
- Ability to view previous orders

For IPI staff, we are now able to better track the usage of the website than previously. At a glance, we can see how many visits our website is receiving, the most popular pages, how many orders have been placed, how our visitors found the IPI website and other statistics. In fact, in the first month after the upgrade, 110 orders were placed on the website for almost \$200,000 in product.

The largest change to the IPI website, and for IPI as an organization, is the acceptance of credit cards. Many customers request to use credit cards, or p-cards, versus traditional purchase orders. With the many regulations in place regarding

credit card processing, IPI is venturing into this process via the website only. This ensures our customer's sensitive data remains secure and saves IPI the costs of meeting various compliance guidelines.

As much work has been put into the new website already, we still have plans for future improvements. Currently, we are working on the large task of adding commonly ordered signs to the website

With the merger, IPI has a greater capacity to fulfill home cabinet orders along with providing wood (for staining) or poplar (for painting) baseboard and window casings for Habitat for Humanity homes throughout the State of Iowa. Habitat homes have been well known for the exceptional quality of the cabinets installed in them, and IPI looks forward to continuing this tradition.

With each home the affiliate receives a child's rocker to be used as a fund-raiser or,

in some cases, the affiliate donates the chair to family receiving the home.

Fort Madison was pleased to hire a number of talented offenders and two staff, Bryan Koechle and Kelly Johnson, from the Habitat cabinetry shop. Both Bryan and Kelly started their careers with the DOC as Correctional Officers before advancing into the Habitat program. The knowledge, experience and talent of Bryan, Kelly and the offenders has been instrumental in keeping the transition from the ISP shop to the IPI shop as seamless as possible for both Habitat for Humanity and IPI.

Mount Pleasant has doubled its inmate workforce to forty offenders to increase production. The Fort Madison shop has also increased inmate work hours.

## **Shop Spotlight: Braille**

This month's spotlight is on our Braille Shop. To our customers, we are known as Anamosa Braille Center, and the program has been providing products for the sight impaired for over 15 years. Since we have last visited the Braille program in 2008, the shop has experienced several changes. From approximately 19 offenders then to 25 currently, the goal for each offender to gain a nationally recognized certification has not changed. Today, we have 17 literary (text) transcribers of which 12 are certified. Five have reached the Nemeth (math) transcription level, and two have advanced to the music Braille certification. The Braille shop also has a satellite program at the Newton Correctional Facility with five offenders participating in continuing their development.

Senior Technician Lennie Miller is responsible for the daily activities of the shop. He, along with help from Supervisor Greg Hart, have worked toward developing

a Braille textbook formats course that has been accepted by the National Federation for the Blind as adequate in preparing transcribers for advanced certifications. In addition to this, they have been working in conjunction with Graphic Arts division to provide large print books which will address another need from sight impaired students.

While the Braille operation benefits our customers on a daily basis with the quality work of the offenders,

we also receive reminders of the value that work provides to the offenders. A recent email from ASP Warden Fayram regarding a letter he received from offender's father highlights this.

"I received a letter this month from a man who annually travels from Arizona to see his son ... In the letter, he is very complimentary towards the staff with whom he had the opportunity to interact. He says he was treated "wonderfully", with kindness and courtesy by all staff. He thanked you for "such professionalism".

"I too, wish to thank you. You obviously have represented ASP very well and I appreciate the manner in which you treated him. To a degree, it is human nature for people to take positive things for granted

and only share their negative concerns. I want you to know that the positive way that you perform your duties does make a difference to people, even if we don't hear it from them regularly. He goes on to thank the staff of ASP for the "vast improvement" he sees in his son each year. He credits staff with the way they conduct themselves, as well as specifically crediting the job he has in Braille.

"At times, our jobs are very challenging and difficult. It would be easy to allow negativity to prevail, but letters like this point out that we are above that. Thank you for the work you do every day, but more importantly, for the way in which you do it. It does get noticed and it does make a difference."

### Canteen Experiences Busy Holiday Season

As we have in years past, the Central Canteen provided a free gift bag to all 9,000 Iowa inmates. It consisted of a Ramen noodle soup, meat stick, Smarties, and a candy cane. Over the years, the Canteen has refined this process to a fine art, completing the assembly of the 9,000 bags in just four days after the day's regular processing.

The Central Canteen also offered two sizes of gift bags (\$15.00 and \$25.00) for inmate's friends and families to purchase for them. It continues to be, as in previous years and despite the economy, a success. A total of 3,183 gift bags were sold (34% participation). Each year this program presents a special challenge for the

A big part of the Canteen system is the delivery process, more particularly the job of our dedicated drivers. Five routes are driven each week covering approximately 2,200 miles. A big thank you for their efforts to this sometimes challenging task.

Canteen. As with the free gift bags, all of the assembly for these gift bags takes place after the day's regular processing. The extra amount of needed specialty product also presents the challenge of finding storage space for it, as well as space for the completed gift bags. This year as much as 75% of the Canteen's inmate workers had never experienced processing through the holiday season. It was quite the eye opening experience for them. But with the help of the "veterans," in the end it all worked out.

Something new and extra nice was done by a group of volunteers involved at the Mitchellville institution. The group purchased and donated 259 of the \$15.00

# Spring Catalog In The Works

Work has begun on the upcoming spring Central Canteen catalog. Some of the new items to look for will be those for the more health conscious. The catalog should be ready for implementation around the beginning of March.

### **Greening Iowa: Cleaning Chemicals**

In April 2010, House File 823 was enacted, requiring public schools, community colleges, institutions under the State Board of Regents, and State Agencies to comply with an environmentally preferable cleaning and maintenance policy.

Before this mandate was enacted, IPI had already assisted DAS in converting the Capitol Complex to green cleaning chemicals back in 2008 and Iowa State University facilities in 2009 with our TerraGreen line of Green Seal certified cleaning chemicals. A number of other State facilities such as Camp Dodge Department of Defense and Glenwood Resource Center have also already converted to green with IPI's assistance.

The conversion from traditional cleaning chemicals to green cleaning

chemicals at large facilities can be a fairly time-intensive process. Many variables such as dispenser type and location, current product inventory and current staffing must be taken into account to determine how to best complete the conversion and train staff on correct usage of the new products.

Iowa Prison Industries is currently working with the DOC prisons and districts as well as DHS institutions to ensure their mandated transition to green cleaning chemicals is completed on time and as seamlessly as possible. IPI sales representatives are visiting each institution and, with the facility's assistance, is conducting a free assessment of their dispensers, current products and overall facility needs. Mitchellville Housekeeping & Chemicals

is taking this data and preparing a proposal for each customer, which will include product, dispenser and training recommendations. The conversion and training process will then begin according to a mutually agreeable schedule to ensure these State facilities are meeting the mandate in a timely fashion.

IPI is also offering these assessments at no charge to school districts and community colleges across Iowa. We look forward to assisting as many customers as possible in their transition to green cleaning chemicals.

# Local Business Offers Post-Release Employment Opportunities

A critical component of the Iowa Prison Industries vision is to provide vital work programs that will ensure the offenders' chances of a successful return to society as tax-paying citizens upon their release. In keeping with this vision, IPI Mitchellville staff endeavors to assist its offender-workers in their post-release job searches by helping with resume writing, providing references, and posting information about jobs related to their IPI training.

Through the generosity and openmindedness of the owners of John Boyt Industrial Sewing in Urbandale, Iowa, IPI Mitchellville is now able to provide a golden post-release employment opportunity for its offender-workers. On September 12th, Mr. Boyt and son visited IPI Mitchellville and spoke to 60 offender-workers about employment at their short-run custom sewing business. The Boyts brought numerous examples of the customer-driven custom products sewn by their company, including everything from leather motorcycle bags to canvas binder covers. They described their business and the qualities and technical skills they are looking for in employees,

then provided details about wages, benefits, and advancement opportunities.

After speaking with the group, the Boyts interviewed four soon-to-be-released IPI offender-workers for possible employment with their business. The Boyts have provided IPI Mitchellville with job applications for offenders nearing release and indicated that they will come back to IPI MV to conduct more interviews as needed.

This partnership with the John Boyt Industrial Sewing Company is a win-

win-win for the Boyt Co., IPI, and IPI offender-workers. The John Boyt Co. has steadily growing labor needs that have not been met through advertising in the general public. By teaming up with IPI Mitchellville, the Boyt Co. is increasing their hiring options while helping Iowa offenders become successful tax-paying citizens after release. We at IPI MV look forward to continuing this partnership and to helping provide additional post-release employment opportunities in the future.

#### Special Frame For A Special Flag

IPI Mitchellville recently had the honor of framing a very large, very special flag and three certificates for Governor Branstad. The four by six foot flag, which was presented to Gov. Branstad by the 168th Infantry of the Iowa Army National Guard, was originally flown for six months during their deployment in Afghanistan in support of Operation Enduring Freedom. The certificates framed to the right of the flag give details about the service and base location of the 168th while in Afghanistan, welcome the 168th home, and detail the



Infantry's history. The flag is a proud reminder of the service provided by the over 700 soldiers of Iowa's 168th Infantry, and IPI Mitchellville was proud to be able to frame it.

#### **MHC Expanding Green Offering**

As we move closer to the July 1, 2012, deadline for Iowa's state-wide "Green" mandate, Mitchellville Housekeeping/ Chemicals Division is supporting this initiative by taking steps to transition to more environmentally-friendly product offerings and production. We are currently working closely with our customers to

help them move toward the new Green products in a streamlined manner. We are also working to achieve on-site Green Seal production certification. Although this transition will require new equipment and additional labor, we at MHC are dedicated to the process of becoming a greater part of the state-wide Green movement.

# Office & School Apparel Moves to MV

In October, Custom Office & School Apparel moved from Fort Madison to Mitchellville. The embroidery, fabric printing, and heat sealing equipment brought an exciting new learning opportunity for staff and offenders alike; four offenders and one staff person received training through Axion America. Production began immediately after the training and has not stopped since. In November and December, the women embroidered and printed 449 pieces of clothing totaling over \$2,000 in sales.

### **DES MOINES**

#### Let It Snow!!

The Moving & Install Program has worked with the City of Des Moines Fleet in maintaining their winter snow removal equipment. During each "snow event" the City of Des Moines may dispatch up to 87 dump trucks armed with brine, salt or sand mixtures to treat and clear the streets of the city. This equipment gets incredibly dirty from the street and the materials they are dispersing.

The City of Des Moines expects that by IPI washing this equipment, the useful life of the vehicles will be extended by another year or two.

The Moving & Install Program has also been working with DAS in clearing snow from the walkways and emergency exits from the buildings on the Capital Complex. After each snow event, two teams of workers and staff are dispatched to the Complex to clear the exits of more than 15 different buildings and walkways. This can be time intensive, depending on factors such as the amount of snow received and the wind direction. Some locations take as little as a couple of minutes, while other buildings take a couple of hours.
